

## PASSENGER RAIL PRIORITIES PROGRAM 2023 PILOT PROGRAM SUMMARY

The Metropolitan Planning Organization Advisory Council (MPOAC) Freight & Rail Committee (FRC) developed the Passenger Rail Priorities Program (PRPP) to identify and promote high-priority intercity passenger rail projects within the planning boundaries of Florida's Metropolitan Planning Organizations for consideration in FDOT intercity passenger rail planning efforts and other potential funding sources. The PRPP's objective is to collaboratively develop a comprehensive list of projects representing the united input of the MPOAC. The MPOAC updates and endorses the PRPP project list annually.

### Project Selection Overview

The PRPP Project List contains all project submissions that passed the agreed-upon requirements set by the FRC. Eligible intercity passenger rail projects include corridor studies, restoration of former Amtrak services, and station development. Project applications were vetted for program eligibility and how they aligned with FDOT's State Rail Plan. The 2023 Pilot Program's critical activities included:

1. The training webinar was conducted virtually on November 7, 2023. The training session covered project eligibility and a demonstration of how to complete the electronic application.
2. The project submission period began on November 8, 2023, and remained open until December 8, 2023.
3. Project submissions were reviewed for completeness, and MPOs could make updates to their applications. One-on-one technical assistance was made available to answer specific questions.
4. The design and development of an online web portal for future PRPP submissions using 2023 Pilot application data.

### Summary of the 2024 Pilot PRPP Project List

- Five Applications were received from eight MPOs, including one joint Application.
- All projects align with FDOT State Rail Plan Tier I, II, and III corridors.
- Three projects seek to develop new intercity passenger rail services, while two projects aim to restore services.
- Three projects seek funding for construction activities, and two projects seek funding for rail planning corridor studies.

### Next Steps and Resources

Projects submitted for the 2023 PRPP Pilot will be validated by their respective MPOs and rolled into the 2024 Application Cycle, opening in September 2024. MPOs with incomplete applications will be able to complete the missing information for consideration in the 2024 PRPP Priority List, which will be adopted by the FRC, the Staff Director's Advisory Committee, and the Governing Board in January 2025.
